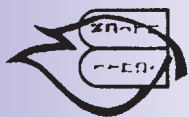

The information highway for the Canon Law Society of America will increase significantly under Jim's management. At the old site, the possibility existed to order books from CLSA Publications with a credit card and some easy to follow instructions which date back to the creation of this part of the website by the Electronic's committee. The renewed site increases our ability. For example, web users may now participate in CLSA Pre-publication special offers as well as research current and past seminar presentations from CLSA Proceedings.

The updated CLSA web site offers members greater opportunities for communication links to other web sites. For example a list of United States Catholic Dioceses by state or a listing of Catholic bishops in the United States is available by linking to <http://www.usccb.org/dioceses.htm>. These links offer more than simply names and addresses. Particular legislation and policies in place in many dioceses become readily available. For example, questions concerning Canon 220 with respect to the right to a good reputation and privacy come to life with items

such as fingerprinting information found at <http://www.catholiccincinnati.org/admin/perso/c-fingerprinting.htm>. Our members and those interested in canon law will find the new website a useful and valuable resource for study.

The CLSA is advertising a special *Pre-Publication Offer* for its newest publication, *In Time of Need: Parishes and Canon 517, §2*, authored by Sr. Therese Guerin Sullivan and Rev. Gary D. Yanus. This is a supplemental guide dealing with situations when, due to a shortage of priests, the diocesan bishop deems it necessary to entrust a share of the sacramental pastoral care of a parish to one or more persons who are not priests. It focuses on parishes without a resident pastor, church teachings regarding the role of the priest in parish life, the role of the layperson who directs the pastoral care of the parish, and the use of deacons and other laity in accom-



plishing this. It is a handy and useful resource and tool for diocesan and parish councils, and well as clergy and laity involved in parochial life.

Board Stresses the Need for Strategic Planning

In late January the Board of Governors met in Orlando, Florida, while much of the Northeast and mid-Atlantic region was digging out from a very substantial snowstorm. As a result of the weather conditions, airport closings and numerous cancellations and delays, Msgr. Daniel Hoye, CLSA Vice-President/President-Elect, was not able to be with us despite his repeated attempts to join us. In addition, following our meeting several members of the board were stranded in different parts of the country as a result of a series of ice storms that blanketed the South. Needless to say, we hope travel to our April board meeting will be less eventful and more comfortable.

The board addressed numerous agenda items during its meeting, many of which support the need for the Society to engage in strategic planning for its future direction and to determine what the Society wishes to accomplish in service to its members and to the Church. Issues, for example, related to the preparation, production and handling of publications, the use of electronic media, collaboration with other national organizations, the canonical needs of Spanish-speaking people, the role of education and advocacy in the work of the Society, and the availability of resources for carrying out the mission of the CLSA all point to the importance of such planning for both the immediate and long-term future. Msgr. Mark Bartchak, Past President, chairs the CLSA Planning Task Force, established in 2002 by Past President Rev. Lawrence O'Keefe and revised in 2004 by the Board of Governors. The Board discussed how best to involve the entire membership in

our planning for the future and will be reporting more about such opportunities later this year.

Another important topic on the Board's agenda concerned the status of the 2005 *Membership Directory*. Following consultation with the Electronic Committee, a decision will be made regarding the possibility of publishing the new directory electroni-

cally this year. Elsewhere in this *Newsletter* you can read about the new CLSA website and the information that has been added to the site. We are grateful to Father Art Espelage, Executive Coordinator and our Webmaster, Mr. James Frenette of Burke, Virginia, for their work in creating and maintaining the new site.

Despite the fluctuating weather patterns throughout the country we have been able to attend several events involving members of the Society or other Catholic organizations. In November I attended the USCCB meeting as an observer, as Msgr. Mark Bartchak had done in 2003. Just as Mark had experienced last year, the bishops were pleased that the CLSA president was attending as an observer; they were eager to express their grati-

tude for the work their own canonists and the society are doing to assist them particularly in processing the cases of sexual abuse of minors. The level of apprehensive surrounding the application of the canonical procedures was not as high as it had been due, in a significant way, to the help the society has provided over the past two years. In identifying how the society might further assist bishops, several mentioned the tremendous need for advocates, particularly for those accused of sexual misconduct.

In early December, I traveled to Lake Charles, Louisiana for the 53rd Annual Convention of the Conference of Chancery and Tribunal Officials of the Provinces of New Orleans and Mobile. The gracious hospitality of Msgr. Jace Eskind, president of the conference, and the excellent program afforded me the opportunity to experience first hand the exceptional work of our members in this area of the country, and the service they provide to our mission dioceses. Sr. Marilyn Vassalo, CSJ led one tract of the conference in Advocate Training while Bishop Thomas Paprocki led the second tract on “Obedience: Virtuous or Virtual Reality?” I was invited to address the membership during the business meeting for an update on CLSA activities and responded to questions raised by the members.

Two other gatherings to which I was invited each dealt with collaboration and consultation in the Church, a theme that is generating increased interest in various sectors of the Church today. Collaboration of the Society with other national organizations (for example, the Conference for Pastoral Planning and Council Development, National Association of Church Personnel Administrators, National Association for Lay Ministry, National Pastoral Life Center) around issues of

In Memoriam

The Executive Coordinator's Office received notification of the passing of the **Reverend Edmund Francis Carroll, TOR.**

An associate member of the CLSA since 2001, Father Carroll served as a collegiate judge in the Diocese of Arlington, Virginia before moving to the provincial residence in Pittsburgh, Pennsylvania and then to Basyne, Virginia. No further details are available.

The **Reverend James Bonaventure Zusy, OP**, passed away July 3, 2004 at age 71. He was a member of the Dominican Friars of the Province of St. Albert the Great. Born in Milwaukee, Wisconsin on July 8, 1932 he was ordained May 23, 1959. Over the years he served at parishes in the United States and also the Nigerian African Missions at Yelwa, Sokoto, Guisau and Yaba, Lagos, Nigeria, West Africa from 1960 to 1968. He completed his canon law studies at St. Paul University, Ottawa, Ontario between 1976-1980. Many CLSA members will remember his thesis topic: Immaturity for Marriage from a Psychological and Canonical Viewpoint as a basis for LDD. As a canonist, Fr. Zusy served as adjutant or judicial vicar in a number of tribunals: The Military Ordinariate from 1980-1982; Fort Worth, Texas 1982-1986; St. Paul-Minneapolis, Minnesota, 1986-1995; and Lexington, Kentucky 1995-2004. Over the years, he attended the CLSA national and regional conventions and also conducted numerous update workshops. His funeral service took place at St. Pius V Catholic Church, Chicago on July 7, 2004.

Graduates of the Catholic University of America, Washington, DC, will be saddened to learn of the passing of **Mrs. Priscilla Marquez** who died January 7, 2005. For thirteen years, she was the administrative assistant in the 1974 Department of Canon Law at The Catholic University of America (1974 to 1987). Priscilla will be remembered as a calming and encouraging individual for both faculty, staff, and students. As a

widow, she raised two children, one of whom is a patent attorney in Alexandria, Virginia. As administrative assistant, she helped further the canonical education of so many students in so many little but important ways.

A returned mailing alerted the Executive Coordinator's office of the death of the **Reverend Kenneth. R. Morvant** of the Diocese of Lafayette, Louisiana. A Judicial Vicar of the diocese, Father Morvant earned a BS degree from St. John Seminary in Little Rock, Arkansas in 1957 after earning a BA from the University of Southwestern Louisiana in 1954. He earned his JCL degree from The Catholic University of America in 1991. No further details are known.

The **Reverend John T. Finnegan, Jr.** passed away on February 9, 2005 at *Regina Cleri* Retirement Home in Boston at age 76. Older members will recall that Father Finnegan served as CLSA Vice President being elected at the convention in Boston Massachusetts in October 1968 and then elected at St. Paul, Minnesota as CLSA President in October of 1974. His career was truly memorable. A high school drop out, he became a meter reader for the Boston Gas Company and then attended Holy Cross College before entering the Navy. In 1955 he entered St. John Seminary and was ordained a priest in 1960. After a brief assignment as parish priest, he began his studies of canon law at the Lateran University in Rome and received his JCD. For fifteen years he served as professor of church history and canon law at Pope John XXIII National Seminary in Weston, Massachusetts. During his teaching years, he also held positions at Boston College, Georgetown, Notre Dame and the Weston Jesuit School of Theology. He is survived by four brothers and many other family members. His funeral mass was celebrated at St. Theresa of Avila Church in West Roxbury with burial at Mount Benedict Cemetery in Roxbury, Massachusetts. ▼

leadership in the Church and the involvement of lay men and women in the promoting excellence in church management, finances and human resources, was the focus of one gathering in Washington, DC. A second gathering was the FADICA (Foundations and Donors Interested in Catholic Activities) annual membership meeting whose theme on "Women of Faith" was structured around the 2004 Letter of the Congregation for the Doctrine of the Faith on "The Collaboration of Men and Women." In both these gatherings the participants expressed gratitude for participation by the Canon Law Society of America.

In mid-February, I visited St. Paul's University in Ottawa, Canada to speak with the canon law students and to deliver the annual Glasmacher Lecture at the university. It was heartening to witness the enthusiasm of the students for their canonical studies and to discuss with them the many challenges facing canonists and our Church today. While in Ottawa I had the opportunity to visit with Professors Lynda Robataille, a current BOG member and Rev. Patrick Cogan, a member of the previous BOG. I am grateful to Dean Roland Jacques, OMI for his gracious hospitality and to Msgr. Roch Page, President of the Canadian Canon Law Society, for hosting a dinner following the lecture.

In the days immediately following the publication of the new Instruction *Dignitas Connubii* many of us have been eagerly trying to obtain copies of the new guidelines on marriage annulments. Once we have had the opportunity to review the text, we will decide whether or not a pre-convention workshop or a convention seminar on the Instruction would be helpful to our members.

During this Lenten season, may we be ever mindful of the abiding presence of God in our lives - in those moments of rejection and suffering and the life-giving moments of resurrection. My prayer for each of us is that in opening our hearts to God's mercy and forgiveness we may bring new life to one another and hope to our world. ▼

their orders.) The new instruction contains fifteen titles or chapters and sets forth 308 articles. This Instruction, prepared by the Pontifical Council for Legislative Texts by mandate of the Supreme Pontiff, John Paul II, granted *pro hac vice* on the 4th of February 2003, with the close cooperation of the Congregation of the Doctrine of the Faith, the Congregation for Divine Worship and the Discipline of the Sacraments, the Supreme Tribunal of the Apostolic Signatura and the Tribunal of the Roman Rota was approved by the same Roman Pontiff on the 8th of November 2004, who ordered that it

be observed by those to whom it pertains immediately from the day of its publication, the 25th day of January 2005, the Feast of the Conversion of St. Paul.

- The **Catholic Bishops of Alaska** (Archbishop of Anchorage, Bishops of Juneau and Fairbanks) are in the process, with the approval of the Apostolic Signatura, of establishing an inter diocesan tribunal having competence for judicial cases arising in all three dioceses.
The Bishops are soliciting expressions of interest from degreed canonists who would be qualified to direct the new tribunal on a full-time basis for an initial period of two years, beginning in early 2005. Secular or religious priests would be considered for appointment to the office of judicial vicar. Such appointment would, of course, require the approval

of a priest's ecclesiastical superior.

Deacons and consecrated or secular lay persons would be considered for appointment as tribunal director. It is anticipated that the main office of the new tribunal will be in Anchorage, Alaska, with branch offices in Fairbanks and Southeast Alaska.

In addition to canonical expertise, a successful applicant would require sufficient administrative, communication, and interpersonal skills to oversee the establishment and functioning of a new inter diocesan organization. Sensitivity to the special circumstances of the Catholic Church in Alaska and to the significant differences among the three dioceses would be very important.

Compensation, housing, and other benefits for a priest would be the same as for other secular and religious priests serving in the Archdiocese of Anchorage. Annual salary for a deacon or consecrated or secular layperson would be about \$45,000. Health insurance would also be provided, as would limited assistance with moving expenses. While the initial employment period would be two years, this could be renewed by mutual agreement.
