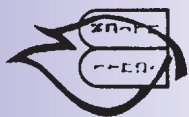

CLSA Representatives Visit Offices of the Holy See

Holy See. In this Newsletter I will report on the meetings with (1): The Roman Rota, (2) the Congregation for the Clergy; and (3) the Congregation for the Doctrine of the Faith. In the

From May 7-12, 2006, the Vice-President of CLSA, Msgr. Stephen Pedone, the Executive Coordinator, the Reverend Arthur Espelage, OFM, and I visited several offices of the

next Newsletter, reports will be made on visits to the Congregation on Consecrated Life, the Apostolic Signatura, and the Sacred Penitentiary.

At the Rota we met with three Judges: Monsignors Robert Sable, Kenneth Boccafolo and Gerald McKay. At the meeting I expressed gratitude for Monsignor Boccafolo's willingness to present a pre-convention workshop on Rotal Jurisprudence at the Fort Worth Convention, October 2006. The officers had a list of five suggested topics.

- Could the Rota offer any guidance on dealing with contentious respondents appealing to delay the process on local and appeal levels?
- Is the Petitioner or Respondent responsible for payments in appeals by a contentious respondent?
- Could the Rota comment on an "average" time line required for the processing of appeals cases at the Rota?
- The CLSA would welcome the opportunity to publish more Rotal decisions in English translations.
- Would the Rota have any material suitable for publication in the CLSA's *Roman Replies* or *Canon Law Digest*?

The major part of the informal discussion focused on the contentious respondent. With respect to the fee of \$850 agreed upon some time ago by the USCCB and the Rota, there is no change. It is the Diocese who sends the money for a case. The Rota requires the Petitioner in the case to have an Advocate and upon receipt of the case will send the Petitioner a list of advocates and other items of an informational nature. The judges pointed out that the actor does not change at the Rota in the event that the Respondent is the one who appeals a case. It is the *judges who* decide whether or not the Respondent must have an

Advocate. The judges pointed out that it would not be proper for a diocese to make the Respondent pay as an indication of the person's serious intention before they would consider sending the case to Rome. Such a procedure could lead to a violation of the right of appeal.

Regarding the length of time an appeal case could be at the Rota, the judges offered their opinion that the normal length, barring problems, would be around two years with a ratification process of approximately six months. Time depends upon the dates of arrival at the Rota as well as the "quality" of the Acts. For example, Acts should number the pages and include a table of contents. On yet another point, the judges noted that it is not necessary to put the three *vota* of a collegiate case into the acts for the Rota. They did stress the importance of interrogating the parties and witnesses as they have noted in the past.

The officers met later with two officials of the Congregation for the Clergy: Msgr. Anthony Mc Daid, Monsignor Gerard O'Connor and Msgr. Raigosa Alzate Jorge. The issue of dispensations from the obligations which arise from sacred orders was discussed. As of August 1, 2005, competence for the cases was transferred from the Congregation for the Sacraments to the Congregation for the Clergy. Those cases already given a protocol by the Congregation for the Sacraments remain with that dicastery. At the present time, the same formularies used in the past to present cases to the Holy Father will continue. Normally, if a case is submitted for a priest under the age of forty, the case will be kept on file and activated when the priest reaches the standard age of 40.

We also spoke about the dispensing a permanent deacon so he could remarry after the death of his spouse. The

Charlene was a woman of great faith who loved the law. She will be greatly missed by many family, friends, and colleagues. Charlene joined the Canon Law Society in March of 1981. She had earned a B.A. in Theology in 1974 from Seattle University and an M.A. in Theology in 1977 from St. Thomas Major Seminary, Kenmore, Washington. From 1979 onwards Charlene was associated with the Tribunal office of the Archdiocese during which time she received a MS degree in Counseling from Seattle Pacific University in 1984 before enrolling at the Faculty of Canon Law, St. Paul University, Ottawa, Ontario, Canada where she earned a JCB in 1990 and a JCL in 1991. Charlene's legal passion was for the rights of individuals. She was particularly interested in the Rights of Respondents in Marriage Nullity Cases, the protection of the rights of the Christian Faithful. Truly a kind and generous lady, the CLSA and the Catholic Church in Seattle was blessed to have her among us.

■ The Diocese of Brownsville announced that we are saddened to announce that **Bishop John J. Fitzpatrick**, who served for 20 years as the third bishop of the Diocese of Brownsville, passed away this afternoon (Saturday, July 15) at his home. He was living in the rectory at St. Mary, Mother of the Church in Brownsville.

"Bishop John Fitzpatrick will be long remembered as a true champion of the poor and underprivileged. His outreach to farm workers and refugees was note-

worthy. He was a quiet, simple man who served the Church with fidelity and steadfastness. All the bishops of Texas who served during his time held him in high esteem and will remember him fondly," said Bishop Raymundo J. Peña.

Bishop Fitzpatrick, age 87, was appointed bishop of the Diocese of Brownsville on April 12, 1971 and installed at the Immaculate Conception Cathedral on May 27, 1971. He retired on Nov. 30, 1991 and remained in Brownsville throughout his retirement, where he continued celebrating Mass at St. Mary, Mother of the Church in Brownsville.

He was born on Oct. 12, 1918 in Trenton, Ontario, Canada and grew up in western New York where he attended Catholic grammar school and the diocesan preparatory seminary. He pursued his studies at the Seminary for the Propagation of the Faith in Rome and the Seminary of Our Lady of the Angels in Niagara Falls, New York. He was ordained on Dec. 13, 1942 for the Diocese of Buffalo, where he served in several parishes before going to Florida in 1948.

While in Florida he was pastor of several parishes, editor of two diocesan newspapers, director of the oldest Marian Shrines in the United States, and director of the archdiocesan program for Cuban refugees. He was also involved in the Christian Family Movement and the Cursillo Movement.

He was consecrated Auxiliary Bishop of Miami on Aug. 28, 1968, three years before his appointment to the Brownsville Diocese. A member of the Canon Law Society of America since 1982, when he wrote, "my reason for wanting to join is precisely to attend the national meetings – with an eye to implementing the revised code as knowledgeably as possible.

The board of governors will offer a resolution for a proposed constitutional amendment at the Fort Worth Convention. Prepared by Br. Patrick Shea, O.F.M. and Rev. Gregory Bittner, the substance of the proposal is reported below.

Proposed Amendments

Constitutions

Art. VII, §7 Of the seven Consultors, one shall *ex officio* be the immediate past President, whose term of office as Consultor shall extend for the entire time that his or her successor as President is in office. Six Consultors shall be elected to terms of ~~two~~ **three** years. Their elections shall be so

arranged that ~~three~~ **two** Consultors are elected each year.

Art. IX, §3. The President and Vice President shall hold office for one year; the Secretary, Treasurer and the elected Consultors shall hold office for ~~two~~ **three** years. Terms of office shall end at the close of the Annual Meeting at which new officers are elected. **The terms of the Secretary and Treasurer shall end in different years so that both do not go out of office in the same year.**

By-Laws

§17(b) For the election of Consultors:

There shall be at least ~~six~~ **four** nominees for the office of Consultor, plus any others who may be nominated from the floor. Members shall, on one ballot, vote for ~~three~~ **two** Consultors. If anyone names the same Consultor twice, that vote for this office shall be considered invalid. An election shall be determined by an absolute majority of the active members present and voting.

- If an absolute majority is not reached by anyone on the ballot, the names of the top ~~four~~ **three** candidates shall again be proposed to the electorate. Again the membership shall vote for ~~three~~ **two** candidates. The ~~three~~ **two**

with the highest number of votes are considered elected.

- If in the first ballot only one person receives an absolute majority, the other top ~~three~~ **two** candidates shall be placed on the second ballot. The ~~two~~ **one** with the most number of votes ~~are~~ **is** considered elected.
- ~~If in the first ballot only two person receive an absolute majority, the other top two candidates shall be placed on the second ballot~~
- (3) If on the first ballot, there are ~~four~~ **three** or ~~five~~ **four** persons who have received a majority of the votes, the ~~three~~ **two** with the most votes shall be considered elected.

Effective Date

These amendments shall fully take effect no more than two (2) years from the date of passage. During the two year interval before it takes effect, the Board of Governors shall devise and implement a transition plan by which it will be so arranged that two Consultors are elected each year. The Board of Governors may do this by arranging that some Consultors are elected or selected for terms of one, two or three years so that the Consultors may ultimately be divided into three groups of two so that two are elected each year. ▼

Elected to the Old Brotherhood of the English Secular Clergy 1987, Secretary 1992. Appointed Proto notary Apostolic 2000. Hon. Italy. Over the years, he worked tirelessly in Brownsville, Austin, and San Antonio. At the time of his passing, Father Ray was Defender of the Bond for the 2nd instance Court of Appeal for the Dioceses of Texas as well as parochial vicar of Our Lady of Guadalupe Catholic Church in Midland, Texas. original requirements the dispensation were (1) minor children; (2) aged parents who are dependent; (3) the bishop needs the deacon for ministry in the church. Originally all three were needed; under Pope John Paul II only one of three was needed for deacon dispensation; now under Pope Benedict XVI, two of three (minor children and necessity of the deacons service) are needed. There was a brief discussion of the implications of canon 1044 on irregularities for those who proceed without the proper dispensations, but this is an area under study by a number of congregations.

As for transmittal of cases involving deacons to the congregation, only one copy of the *acta* is necessary (3 copies remain for dispensations for priests) The congregation outlined the procedure for the preparation of the *votum* for the Holy Father. The basic outline of a marriage procedure case would be an analogous procedure.

There was also a short discussion of the use of psychological assessments and reports from formation personnel being placed in the dispensation *acta*. If these materials do not exist, state this fact; if other materials can be inserted, i.e. testimony from peers, this might be helpful. A case of *articulo mortis* was also cited. This should be noted on the first page of the Acts. If a request is made immediately after leaving active ministry, there should be indication exactly what the ordinary did to return

the man to the active ministry.

The Congregation wished to emphasize that it remains very committed to defending the rights of priests. The final segment of this report deals with the meeting at the Congregation for the Doctrine of the Faith. We met with Cardinal William Levada, and Monsignors Charles Scicluna and Robert Deeley. I presented some possible discussion topics offered by CLSA members.

- Regarding SST, what is the most effective way from the CDF's perspective for communication regarding specific cases? Does the congregation prefer that the bishop communicate with the prefect or for a delegate of the bishop to communicate with a staff member?
- Similarly, how can the rights of an accused priest be appropriately addressed in light of justice? How can advocates effectively communicate with the congregation?
- Is there any possibility of knowing how many cases have been presented, resolved, and still remain pending? Even a percentage number might be helpful to the members to understand the scope of the issue.
- Is there a time-frame limitation beyond which, in justice, a preliminary investigation should be brought to a conclusion?
- Since the CDF does not publish its jurisprudence, could the congregation suggest how canonists might benefit from the experience in recent years?

- Could the congregation comment as to any significance to the revised wording of the CDF decrees that mention "for the good of the church?"
- If canon 223 should be employed to remove a priest from active ministry, is the CDF competent to hear an appeal when non-penal case hints of sexual abuse of a minor but cannot be substantiated and judgment is made for the common good that the priest should not function in active ministry? In a related case, what about matters not involving sexual abuse of a minor. Could the congregation comment on appeal relationships with itself and the Apostolic Signatura?
- As a point of praxis, as a case comes to a close, what, if anything, can be made public about the disposition of a case?
- Could the congregation offer any comments concerning sustenance for a cleric accused of sexual abuse of a minor who is not laicized but no longer publicly functioning in active ministry?
- Would the congregation have any materials which might be published by the CLSA in *Roman Replies* and *Canon Law Digest*?

Due to time constraints, not all of these topics were discussed.

We began with a series of comments provided by the Officials. The Congregation deals directly with bishops. While auxiliary questions can be addressed by staff, their responses are unofficial. ▼
